22/174	Matters arising / Actions from Previous Minutes (1) speed limits A56: TW Confirmed Highways will not reconsider the speed limits PC resolved not to take this any further (2) A553 Crossing, - TW confirmed no response from the generic email for national highways – JH to send TW direct email so TW can investigate this further (3) Coronation Event -Although 1 member of the public has volunteered to assist, no further help has been forthcoming. PC to have further discussions before the next meeting on what event to organise. (5) Streetlight – TW confirmed she had emailed 2 members from highways, with regards to this, awaiting a full response. (6) Planter – Cedar Avenue - Resolved to replace the planter, Cllr’s to check the measurements and supply to TW to obtain a price for the planter. (7) Playground – TW supplied the PC with up to date costings, Cllr’s to have a thorough look at costing and advise which option to go for before asking Architect to go to tender stage.	TW TW

22/176	Public Participation – MOP enquired about the state of the footpaths, holes etc. TW suggested that they use the app on the CWAC website to report them, Cllr’s agreed to walk around the village and use the app to report. MOP asked about the possibility of a Zebra crossing on Chester Road – BS advised that the cost of this would be @£250,000, Highways also have to have permission from houses near by and all Zebra Crossing now have to have lights. Highways will not entertain it, it would be down to the PC, and PC cannot afford it. Email -Grit Boxes – TW has received a request for grit boxes – Whilst the PC feel that the boxes wont work, they are happy to contact CWAC for a supply of grit, to be stored at HB, where MOP can collect – to organise ready for winter 2023. MOP asked about having more Speed Indicator Display signs – TW advised of the cost of these. As the PC has already set the budget/precept they can’t be considered until 2024-25 financial year.
